I further confirm that everything declared by me or by the Minor during the event shall be truthful and shall not infringe upon the rights of third parties.

I release WORLD EVENTS SRLS from any liability in connection with any incident that may occur to me or to the Minor as a result of participation in the event, declaring in particular that my physical and athletic abilities, or those of the Minor, allow the performance of the activities required, as certified by the medical certificate in my possession. I further declare that I am in possession of, or will independently obtain, adequate insurance coverage, acknowledging that WORLD EVENTS SRLS has not charged me any fee for membership and/or insurance and that, therefore, I am fully aware that this service is not included.

IPRIVACY NOTICE pursuant to Article 13 of Regulation (EU) 2016/679

Dear Sir/Madam,

As Data Controllers, we wish to inform you that Regulation (EU) 2016/679 – General Data Protection Regulation (G.D.P.R.), directly applicable in Italy, pending the issuance of the Decree provided by Community Law no. 163/2017, ensures the protection of individuals and other subjects with regard to the processing of personal data. According to this Regulation, such processing will be based on principles of fairness, lawfulness, transparency, and the protection of your privacy and rights.

Pursuant to Article 13 of the G.D.P.R., we therefore provide you with the following information:

- 1.** The personal and contact data you provide will be processed for the following purposes, based on your consent and on the legitimate interests of the Company: the data will be collected for internal purposes of the Company and will NEVER be disclosed.
- 2.** The legal basis of such processing is Article 36 of the Italian Civil Code, fiscal regulations relating to non-commercial entities, in particular Article 148 of the T.U.I.R., Article 4 of D.P.R. 633/72, and Article 90 of Law 289/2002, as well as the regulations of CONI and sports federations concerning membership and participation in activities organized by or with the participation of such entities.
- 3.** The legitimate interests pursued by the Data Controller through such processing are: a clear and correct application of the statutory provisions on internal governance and the administration of the association, the possibility of benefiting from the tax advantages available to the association, and the possibility of participating in the activities organized by the entities mentioned in point 1 above.
- 4.** Processing will be carried out in the following manner: on manual records, also with the aid of electronic means, kept in locked premises whose key is held by the President and the persons in charge of administration, or in digital form, on a computer located at the headquarters of the Association, adequately protected against IT risks (firewall, antivirus, periodic data backup). Authorized persons with access to such data are the President and the persons in charge of administration. Pursuant to Article 4(2) of the G.D.P.R., the processing of personal data may consist of collection, recording, organization, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, erasure, and destruction of the data.
- 5.** Personal data will be stored for the period necessary to ensure proper organizational management of the event. This period is determined by the Italian Civil Code and by fiscal regulations. Verification of the obsolescence of the data in relation to the purposes for which they were collected and processed will be carried out periodically.
- 6.** The processing will not concern personal data falling within the category of “special categories of data,” i.e. data revealing racial or ethnic origin, religious, philosophical, or other beliefs, political opinions, membership in parties, trade unions, associations, or organizations of a religious, philosophical, political, or trade-union nature, as well as data revealing health status or sexual life.

- 8.** The Data Processor is Mr. Giovanni Micoli, Director of WORLD EVENTS SRLS, contactable at the same email address: **worldeventssrls@gmail.com**
- 9.** At any time, you may exercise your rights to know what data concerning you is held, to know how it was acquired, to verify whether it is accurate, complete, up-to-date, and securely stored, to receive the data in a structured, commonly used, and machine-readable format, to withdraw any consent previously given regarding the processing of your data at any time, and to object, in whole or in part, to its use, as provided for in Articles 15–20 of the G.D.P.R. Such rights may be exercised by sending a specific request by registered mail to the addresses indicated in point 9 above, or by certified email (PEC) to the Data Controller.
- 10.** You have the right to withdraw consent at any time without affecting the lawfulness of processing based on consent before its withdrawal. This right may be exercised by sending notice of withdrawal to the email address indicated in points 7 or 8 above.
- 11.** You have the right to lodge a complaint with the Italian Data Protection Authority (Garante per la protezione dei dati personali) or with another supervisory authority that may be established pursuant to the Decree provided by Community Law no. 163/2017.
- 12.** There is no automated decision-making process, nor any profiling activity as referred to in Article 22, paragraphs 1 and 4 of the G.D.P.R.
